### **RESOLUTION 2024-11**

# Authorizing the Charter Township of Ypsilanti to Sell to Purchaser Marie C. Goode Two Vacant Parcels Located at 475 Greenlawn Street and 481 Greenlawn Street

WHEREAS, on or about December 29, 2011 Washtenaw County
Treasurer Catherine McClary, acting in her capacity as the Foreclosing
Governmental Unit (FGU) under the Authority of the General Property
Tax Act (GPTA) foreclosed upon certain properties in the Washtenaw
County Circuit Court due to delinquent real property taxes which included
two vacant parcels located in Ypsilanti Township to wit: 475 Greenlawn
Street and 481 Greenlawn Street and,

WHEREAS, on or about December 30, 2011 the Charter Township of Ypsilanti received a "Quit Claim Deed" from County Treasurer McClary which included the legal descriptions of the two vacant parcels which are as follows:

#### Parcel 1:

**K-11-11-332-028,** 475 Greenlawn St., Ypsilanti, MI 48198 with a legal description of Lot 118 East Lawn Subdivision. Split on 06/04/2004 from K-11-11-332-011,

#### Parcel 2:

K-11-11-332-029, 481 Greenlawn St., Ypsilanti, MI 48198 with a legal description of Lot 117 East Lawn Subdivision. Split on 06/04/2004 from K-11-11-332-011; and

WHEREAS, on July 29, 2022 Marie C. Goode requested of the Ypsilanti Township Assessing Department to purchase the two vacant lots as described above which she intended to combine with her property located at 469 Greenlawn Street which property is contiguous to the Township's two vacant parcels, all of which are located on Greenlawn Street (a copy of said aerial depicting all three lots being attached hereto), and;

WHEREAS, at a regular Board meeting held on August 16, 2022
the Ypsilanti Township Board of Trustees authorized the sale of the two
vacant lots to Purchaser Marie C. Goode which according to the "Market
Valuation Report" prepared by Deputy Assessor Brian McCleery dated
July 29, 2022 are valued at \$7,680, and;

where with the proposed "Purchase Agreement" (a copy of which is attached hereto and incorporated by reference) in which she will remit to the Township the sum of \$7,680 in accordance with the Market Valuation Report dated July 29, 2022.

## NOW, THEREFORE THE YPSILANTI CHARTER TOWNSHIP BOARD OF TRUSTEES HEREBY RESOLVES AS FOLLOWS:

- 1. That the Township Board accept the Purchase Offer submitted hereto and authorize the execution of the "*Purchase Agreement*" by Supervisor Brenda L. Stumbo and Clerk Heather Jarrell Roe.
- 2. That the Township authorize Supervisor Stumbo and Clerk Roe to execute all documents required by Cislo Title to effectuate the transfer of the two vacant parcels to Purchaser Marie C. Goode once a closing date has been scheduled.
- That a certified copy of this Resolution be forwarded to Cislo
   Title as set forth in Paragraph 23 of the Purchase Agreement.


