AFFIDAVIT OF NO RENTAL COMPENSATION

If you are the owner of a property in the Township of Ypsilanti which is currently being occupied by relatives or others, but you are not collecting rent or other monetary, goods, or service compensation you may submit an Affidavit of No Rental Compensation.

The Affidavit of No Rental Compensation is an affidavit meaning that any statements made within are subject to the penalties of perjury. It must be notarized before it will be accepted by the Office of Community Standards.

Section 18-179 of the Township of Ypsilanti requires that no person or entity, either the owner or the owner's responsible local agent, shall rent or lease a residential rental unit unless that owner or agent has first obtained a valid certificate of compliance.

Any person found to be in violation of any section of the Code is subject to a fine ranging from \$100 to \$500 per offense. A separate offense shall be deemed committed each day during or on which a violation or noncompliance occurs or continues.

Please be aware that a complaint for eviction in the district court may be considered as proof of rental occupancy.

If you have filed an affidavit of non-rental and receive a Notice of Violation from the Office of Community Standards stating that you need to register the rental property, please contact the Department to discuss the reason for the notice.

If you have questions regarding the legal implications of filing an Affidavit of No Rental Compensation with regard to any property rights or potential penalties, please consult with an attorney.
