This is official notification that a hearing has been scheduled before the Charter Township of Ypsilanti Board of Trustees to consider revocation of the off-premise liquor license captioned above issued by the Michigan Liquor Control Commission.

The reason for the proposed action is that the Michigan Liquor Control Commission (MLCC) has determined that the licensee has violated the Liquor Control Code by selling or furnishing alcohol to a person under 21 years of age on at least three (3) occasions within a calendar year, and that those violations did not involve the use of false or fraudulent identification by the person under 21 years of age. A Penalty Hearing was held on January 20, 2011 by the MLCC in Southfield and a Penalty Hearing Order was issued on February 23, 2011 by the MLCC, in which it was determined that the subject licensee has been found liable for selling or furnishing alcohol to a person under 21 years of age in violation of MCL 436.1801(2) on the following dates:

- 1. Sale to minor on December 22, 2009
- 2. Sale to minor on December 30, 2009
- 3. Sale to minor on June 10, 2010

Pursuant to MCL 436.1501(3), a local legislative body, by resolution, may request that the commission revoke the license of a licensee granted a license to sell alcoholic liquor for consumption off the premises whose place of business is located within the local legislative body's jurisdiction and who has been determined pursuant to commission violation hearings to have sold or furnished alcoholic liquor, on at least 3 separate occasions in a single calendar year, to a minor if those violations did not involve the use of falsified or fraudulent identification by the minor. If the commission verifies that the licensee who is the subject of the resolution has been found to have committed the violations as prescribed in this subsection, the commission may suspend or revoke the licensee's license and any permit held in conjunction with that license.

Pursuant to Sec. 37-27 of the Charter Township of Ypsilanti Code of Ordinances, each establishment within the township for which a license or permit is granted, whether for consumption of alcohol "onpremises" or "off-premises" shall be operated and maintained in accordance with all applicable state laws, local ordinances, laws and regulations (in addition to the provisions contained in this article), and in a clean and sanitary manner meeting the approval of applicable township departments and policing agencies. Upon any violation of this division, or such other applicable laws, ordinances and regulations, the township board may, after notice and hearing described below, request the state liquor control commission to refuse renewal, revoke, or take such other action as may be required with regard to such licenses. Sec. 37-28 of the township's code of ordinances establishes the procedure and standards for such a hearing, providing guidance to the township board in its deliberations.

The hearing will take place on **Monday**, **July 25**, **2011** at **9:00AM** at the Ypsilanti Township Civic Center board room located at **7200 S**. **Huron River Dr**, **Ypsilanti**, **MI 48197**. The hearing will be held during a special meeting of the Board of Trustees and will be posted and open to the general public pursuant to requirements of the Michigan Open Meetings Act.

At the hearing, you will have an effective opportunity to defend against the allegations made by confronting any adverse witnesses, by presenting witnesses on your behalf, by presenting other evidence on your behalf, and by presenting arguments personally or through legal counsel on your behalf. You have a right to be represented by legal counsel at the hearing.

The township board shall prepare a written statement of its findings within a reasonable time, not to exceed 60 days, after the conclusion of the hearing. If the township board determines after due notice and proper hearing that the licensee has violated the Liquor Control Code by selling or furnishing alcohol to a person under 21 years of age on at least three (3) occasions within a calendar year, and that those violations did not involve the use of false or fraudulent identification by the person under 21 years of age, the board may adopt a resolution requesting that the MLCC revoke the subject license.

Within ten days of the township board's final approval of any such resolution, the township clerk shall forward a copy thereof to the MLCC as the township board's official notice of request for revocation of the subject license and any related permit, a copy of which shall be sent by registered or first class mail to the licensee.

Subject: Tax Foreclosure Auction

The three full- time officials are requesting your support for the authorization to allow the Township Treasurer and Township Attorney to bid on tax foreclosed properties in Ypsilanti Township for the purpose of neighborhood stabilization and economic development.

Habitat for Humanity has agreed to identify and prioritize the single family homes that they believe would be of most interest to landlords and the rental business community. A list of all the Ypsilanti Township tax foreclosed properties is attached.

It is our intention to work with Habitat to deed restrict all homes we purchase (if we are successful in the auction) and resale them to families. The deed restriction would prohibit the resale or rental use of these homes. It is a priority of the Township residents and the Township Board to maintain the quality of life and protect the neighborhoods in our community. Increasing homeownership is paramount to neighborhood stabilization.

The Township is also extremely interested in three commercial properties on E. Michigan Avenue. The Township has already spent a considerable amount of Neighborhood Stabilization funds on E. Michigan Avenue. These three commercial properties need to be preserved for economic development opportunities.

Your consideration and support of this request is deeply appreciated.

Dear Clerk:

This letter serves as your notice of the parcels that I foreclosed upon in Circuit Court in my capacity as the Foreclosing Governmental Unit under the authority of the General Property Tax Act. These foreclosures were made for delinquent real property taxes.

A public auction of these properties is scheduled. Minimum bids have been established and include all delinquent taxes, fees, penalties, and interest plus any costs related to holding the auction. Attached is a list of parcels that have been foreclosed on and may be acquired by your municipality for public use before the public auction for the indicated minimum bid.

The General Property Tax Act establishes a procedure for the State and for local municipalities to purchase foreclosed property prior to public auction. The purchase must be for a governmental use and to carry out a public purpose exempt from taxation. The law establishes the following order of preference:

- a) The State of Michigan has first right of refusal and must pay the higher of the minimum bid or the market value of the property.
- b) The City, Village, or Township (in that order) in which the property is located can purchase the property if the State declines and *must pay the minimum bid.*
- The County may purchase the property if the City, Village, or Township declines and must pay the minimum bid.

If the City, Village, Township, or County purchases a property under this process and later sells the property for more than the purchase price, plus the cost of any improvements, the excess proceeds are due back to the Treasurer to replenish the tax foreclosure fund.

Please let me know as soon as possible if you have any questions about the process for acquiring this parcel or any general questions about foreclosures or charge-backs.


