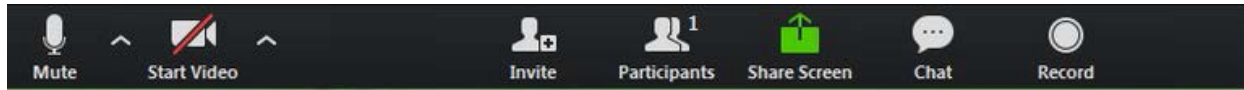

## MEMORANDUM

Subject: **Request to Approve Agenda Item Option A or Agenda Item Option B and the related Budget Amendment as Proposed.**

**Agenda Item Option A:** Request to Purchase 5 Digital Ballot Scanners from Hart Interactive for \$27,725.00 and Accept Grants: 1) \$6,875 from Washtenaw County and 2) \$2,250 from Bureau of Elections for a total cost to Township for the 2020 budget year of \$18,600 and Maintenance and Annual Service Cost of \$14,100.00 to be budgeted in years 2025-2029 for \$2,820.00 per year and approve the related Option A Budget Amendment.

**Agenda Item Option B:** Request to Purchase Verity Central Software and High Speed Ballot Scanner from Hart Interactive for \$124,405.00 and Accept Grants: 1) \$30,000 from Bureau of Elections and 2) \$15,000 from Washtenaw County for the Purchase of Verity Central Software and High Speed Ballot Scanner for total cost to Township for the 2020 budget year of \$79,405 and Maintenance and Annual Service Cost of \$118,000.00 to be budgeted in years 2025-2029 for \$23,600 per year and approve the related Option B Budget Amendment.

Please find in the packet Appendix 1, **Detailed Costs Per Year For 2020-2029 Comparing High Speed Scanner And Regular Scanner For Absent Voter Count Board (AVCB).**

This 10 year cost comparison between the use of the High Speed Scanner and the Regular Scanners for the Absent Voter Count Board include details of the number of inspectors, room rentals and hours related to each type of election that is required per year and also a projection for special elections based on the past historical number of special elections per year over the past 10 years.

Also included in the packet is Appendix 2, **A 10 Year 2020-2029 Summary of Cost Comparison of High Speed Scanner for Absent Voter Count Board (AVCB)**

The grand total of projected AVCB costs for using the high speed scanner for 10 years is **\$320,425** and the grand total of projected AVCB costs for using the regular scanners for 10 years is **\$253,686**. The difference between the costs of the two types of tabulation systems over the 10 years is **\$66,739**. The regular scanner costs over 10 years is **\$66,739** less than the high

speed scanner. **More elections and more years decreases the costs of the high speed scanner costs over the years and the difference between the two systems is diminished.**

**The use of the high speed scanner requires fewer inspectors for each election and shorter hours which results in a safer operation and space for the inspectors in the AVCB.** The number of inspectors in the high speed scanner elections is very conservative. We are working on finding out exactly how many inspectors that other jurisdictions have employed utilizing the high speed scanner.

If the high speed scanner-Option B is not the option approved then the 5 regular scanner-Option A is requested to be approved.

Currently the township has 27 regular scanners and used 19 scanners at the precincts, 5 at the AVCB and three backups during the August 2020 election. The increase in the number of Absentee Voters for the November 2020 election and the future requires the purchase 5 additional scanners. This will provide the township with 32 regular scanners. During the November 2020 election 19 scanners will be employed at the precincts, 10-11 scanners at the AVCB and 2-3 as backups. Each scanner can handle 2,000-2,500 ballots during a 19 hour period. Our projections indicate that 25,000 voters will vote Absentee in November so our need will be for 10-11 regular scanners.

The use of the regular scanners requires a very large number of election inspectors. It was difficult to find inspectors for the August Primary election when less than 11,000 ballots were processed. The November General election is projected to have 25,000 absentee ballots to process. The use of the regular scanners also requires more hours to process the ballots.

As of today Ypsilanti Township has 44,525 registered voters, an increase of 130 voters in just 2 weeks. The number of permanent Absentee Voters is 14,933 an increase of 155 in just 2 weeks. The requests for both new registrations and applications for an absentee ballot are increasing every day. All projections are indicating that with the very large number of permanent absentee voters that the current trend for Absentee Voting will continue over the years and the numbers will increase as the Township population increases.

When one regular scanner is added to meet the increased demand it requires adding 6 additional inspectors to the AVCB. This immediately increases the costs of each election when using the regular scanners and decreases the difference in costs between the use of the high speed scanner and the regular scanners. Adding one regular scanner and the inspectors needed for an additional scanner increase the costs by approximately \$1,600 for one election at the rate of \$13 an hour, which is not a sustainable rate. These costs will increase over time.

A decision to approve the High Speed Scanner purchase, Option B is the best decision for the safety of the inspectors and the long term costs and the future of running elections in Ypsilanti Township.
