WHEREAS, the Charter Township of Ypsilanti, County of Washtenaw, Michigan (the "Township") is authorized by the provisions of Act 281, Public Acts of Michigan, 1986, as amended ("Act 281"), to create a local development finance authority; and

WHEREAS, pursuant to Act 281, the Township Board of the Township duly established the Local Development Finance Authority of the Charter Township of Ypsilanti (the "Authority") which exercises its powers within the District designated by the Township Board (the "District"); and

WHEREAS, in accordance with the provisions of Act 281, the Authority has prepared and approved a Tax Increment Financing and Development Plan (the "Plan"); and

WHEREAS, the Authority has forwarded the Plan to the Township Board requesting its approval of the Plan; and

WHEREAS, prior to approval of the Plan by the Township Board, it is necessary to conduct a public hearing in connection with consideration of the Plan as required by Act 281.

NOW, THEREFORE, BE IT RESOLVED THAT:

 The Township Board hereby acknowledges receipt of the Plan from the Authority and directs the Supervisor and the Township Clerk to advise all local taxing jurisdictions of the

Plan and the Township Board's intention to consider approval of the Plan.

- A public hearing is hereby called for Tuesday the 15th day of August, at 7:30 p.m., Eastern Daylight Time, in the Township Hall in the Township to consider adoption by the Township Board of a resolution approving the Plan.
- 3. The Township Clerk shall cause notice of said public hearing to be published in the *Ann Arbor News*, a newspaper of general circulation in the Township, twice before the public hearing. The first publication of the notice shall be not less than 20 days before the date set for the public hearing. The notice shall be published as a display advertisement prominent in size.
