Mike Hoffmeister: 1) Ford Lake Park boat docks project will be completed in the next week. 2) Loonfeather Park update: No bids previously for Loonfeather project \$296,000 grant so the Township approved new bid, and received 3 new bids. 3) Summer concerts 3 of 5 held (2 canceled due to weather): Clubview, North Bay, Willow Park. 4) Food trucks update: schedule for 2 in Aug and 2 in Sept. 5) Apple Ridge Park survey received limited feedback. Mike would like to hold a community/public meeting so we get appropriate feedback before moving to the Board of Trustees. 6) Name placards on way for public meetings.

Angela Verges: Theater camps underway. New Recreation Coordinator Nicole Passmore started today but she will attend future meetings. Community Center will hold an Open House on Saturday, July 17.

Robin Castle-Hine: We are still collecting money from vendors for Rosie the Riveter festival. 45 vendors registered. Hope to have 55. Need volunteers. Parks weren’t as busy in June due to rain, but still doing very well.
