#### A. Staff Reports

Mike Hoffmeister and John Hines attending out-of-town conference but sent notes:

- 1) Applied for Community Development Block Grants (CDBG) to replace and /or repair Apple Ridge playground
- 2) A second new dock will be installed at Ford Lake boat launch.
- 3) Shelters at Lakeside Park will be reroofed.
- 4) Trash barrels at parks will be replaced this spring.
- 5) The dog park project has been put on hold due to new other projects.
- 6) Residential Services updates include sidewalk repairs, tree removal, and new playground mulch at half of playground before Memorial Day.
- 7) No-cost Covid tests at Rec Center were due to end on February 25<sup>th</sup> but will continue to be offered until March 25.
- 8) Softball leagues will change to double-headers, allowing the township to host 2 seasons instead of only one.
- 9) John is exploring the possibility of a cornhole tournament.
- 10) Nicole is planning to offer three new "50 and Beyond" events.

#### Robin Castle-Hine

Summer Jazz Festival: John E. Lawrence, who has been organizing an annual summer jazz series, wants to hold this year's event at Ford Lake Park on Fridays from July 1 through Sept 2, 7-9 pm. (Last year's event was held at Frog Island.) His team sets up and tears down the stage as well as schedules vendors and food trucks.

Discussion: Commissioner Hodge asked about parking capacity. RCH thinks at least 1,000 cars but will be determined by where the stage is set up. The Township will staff the gate and supply two rangers but will have to charge \$5/car for parking fee. We will also likely need a sheriff's deputy (or two?) for traffic control.

Interview for parks and golf maintenance will be starting soon.

That act indicates that park commissions are to have a role in making decisions about park policies and programs. There needs to be a discussion about the budget and how decisions are made about which projects are prioritized. Pittsfield and Superior have elected park boards and discussions with or observations of their meetings would be helpful for determining what other communities/boards do.
