Josh McCallister asked why West Willow Park's facilities have not been upgraded to same standards as other gated parks. Gate is sometimes locked, other times not. Commissioners will look into situation with township staff.

VII. Reports

A. Staff Reports

Tajalli Hodge, reporting for Mike Hoffmeister, Residential Service Director

- Huron St. Trail Phase 1 is officially complete and our reimbursements from the Washtenaw County Parks & Recreation Commission for our Connecting Communities grant is in process.
- The Clubview Park and Community Center Parks tennis courts renovations will start design soon and will take the rest of 2022. Bidding and construction will take place in 2023. At Sept 12, 2022 meeting, Park Board approved the Community Center Park improvement documents. On 9/14/22, MDNR and National Park Service approved the Clubview Park project and those items were added to the board agenda.
- Township staff, engineers, and legal counsel met about Loonfeather Point Park. Contacted J. Ryan Bonding (JRB), the bonding company for the project, and who will assist the township in pushing PGA to complete the project sooner, before we file a claim against the bond. JRB has contacted PGA and will provide a more detailed answer.

- Willow Run Acres will start work at Appleridge Park for the approved community farm and garden. First phase is construction of the raised flower beds.
- 5 Board of Trustees tabled the ReLeaf tree maintenance agreement for Sugarbrook Park previously approved by Park Board. The main issue is a staffing capabilities. Staff has communicated with ReLeaf and DTE about the decision. In place of these trees, we will go forward with our annual tree planting program and plant trees at Sugarbrook Park (trees have already been ordered.) Tree purchased for annual program come with a 1-year warranty rather than requiring a maintenance agreement.
