Food will be supplied for free; will have permits from county. Hodge also asked about experience; have done several in the past. How many volunteers? 15 – 20 to help run events. Kirby asked about advertising; using social media and word of mouth. If able to get funding, will look for new venues. Hodge asked about types of music: family oriented.

- 1. Fully staffed parks crews.

- 3. Jazz Fest very well attended: 817 paid cars at July 7.

John Hines, Recreation Services Manager and Interim Residential Services Director. Best staff in several years.

ARPA American Rescue Plan Act disbursement Projects: in the May 18 meeting, Township Board allocated monies for parks from federal \$ 15 M grant. Major projects are:

- 1. West Willow Parks \$50K for walking path, structural improvements
- 2. Burns Park: \$250 K for park, walks, and playground
- 3. Community Center \$737 K for replacing galvanized piping, redoing bathrooms
- 4. Ford Heritage Park: \$165 K replace rubber playground surface
- 5. 2 Buses \$225K bid package; one for 14 passengers and handicapped, a second with 15 seats
- 6. Bathrooms at Ford Heritage and Green Oaks: \$850K new at FHP maybe rebuild at Green Oaks
- 7. Community Center Park \$354K for lights on fields 3 & 4 (1 & 2 already lighted.)
- 8. Ford Lake and Lakeside: \$600 k structures improvement/replacement (roofs, maintenance, etc.)

Any money not used will go back into roads. Spicer Group and Stantek Engineering consulted for all projects since all projects will need to go through bid process. Belfour will be separate from ARPA

Hodge: Municipal Services director posted and open till July 14.

B. Commissioner Reports

Commission Hodge: discussed a more proactive approach to funding and initiatives with Director John Hines. Agreed to meet more often to keep abreast of issues.

Approved purchasing agreement for Cheney Elementary School (Superior and Ypsi Township.) Plan to also provide some community services like health advising.

VII. Reports

A. Staff Reports

John Hines, Recreation Services Manager and Interim Residential Services Director.

- 1. Emergency tree trimming services contracted due to severe weather. PPM contractors will do work starting 8/7. Ford Lake Park and Green Oaks took major hits.
- 2. Residential Services Director titled changed to Municipal Services and applications closed July 14.
- 3. Lakeside Park: damage to shelter. Spicer Group visited site and deemed it unsafe. Now closed until it can be renovated sometime in 2024. 6-foot fence installed to keep people away but park is still open.
- 4. Stantek and Spicer Group updates. Community Center is focus to get fixed. Will present finding to Township Board meeting in September and then repair contract will go out to bid; repairs will take longer than originally expected.
- 5. MDNR Clubview plans finally approved; will go to Board for bid. Hope for construction to complete in fall but respondents have been few, prices high.
- 6. Roof work at Ford Lake Park: hope to be finished in late fall.

- 7. Loonfeather Park: submitted request for reimbursement; should finish soon.
- 8. Apple Ridge Park well update. Drilled but not enough flow. Need to re-drill.
- 9. Little bit short staffed but otherwise park operations are working well.
- 10. Green Oaks golf course: tremendous improvement in just one year.

Discussion: Streeter suggested Lakeside Park shelter should be fast-tracked and disassembled now. Hines will take to Spicer Engineering for advice.

B. Commissioner Reports

Commission Hodge reported on the Master Plan process. Survey closed Monday – 800+ responses. Two open houses Aug 23 4:30 - 7:30 at the Community Center and Aug 26 10:00 – 4:00 at North Bay Park.

Elected official and Park Board invited to come an hour early

John Donner of Vanzetti Hamilton Bar Association has proposed a parks clean-up project. Plan to meet 1x or 2x/month to clean litter and improve parks' appearance.

Park application process and revision of guidelines still being reviewed.

Sugarbrook Park update: grounds crew accidentally mowed some garden plots.
