Comments: Resident of Gault Village neighborhood. Concerned about safety and other issues at Nancy Park. Safety: rotted posts and railings in perimeter fence, Soccer net falling away from frame, ground cover under balance beam turning from sand to grass, Picnic table has a loose top, gravel path on the north west end of park eroding. Non-safety: Trees need trimmed and replaced, Park sign needs landscaping. Concerns expressed about ball diamond (on school property, not park). Raised possibility of ice rink in winter. (may not be feasible due to mild winters).

Comments: Lives on north end of Clubview park (stub end of Hillcrest Blvd.) Has concerns about people parking at north end of park. There is a fence at that entrance down, The road is deteriorating. Can the gate be moved closer to Greenside Ave? (no)
