TO THE QUALIFIED ELECTORS OF THE TOWNSHIP OF YPSILANTI:

PLEASE TAKE NOTICE that any qualified elector for the Township of Ypsilanti in the State of Michigan who is not already registered, may register to vote at the office of the Township Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Obtain a registration form or register online at Michigan.gov/vote. Registration forms can be mailed or dropped off to the Township Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, OCTOBER 19, 2026**. After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492 at the: Ypsilanti Township Clerk's Office (7200 S. Huron River Drive, Ypsilanti, MI 48197, phone 734-544-4000, email clerk.elections@ypsitownship.org):

- Regular business hours: Monday - Friday from 8:30 a.m. to 4:30 p.m.
- Saturday, August 1st from 8:00 a.m. to 4:00 p.m.
- Drop boxes: Township Civic Center, Community Center, Fire Stations Hewitt Rd, and Ford Blvd
- Early Voting Saturday October 24th-Sunday November 1st 8:00am-4:00pm except Tuesday October 27th and Thursday October 29th 11:00-7:00pm
- Early Voting Locations Civic Center and Community Center
- Election Day, Tuesday November 3rd from 7 a.m. to 8 p.m. at your polling location, check your voter registration at Michigan.gov/vote
